### Setting up of EV charging station in select parking lots developed along Fatehabad Road

- 1. - 4. At this stage Authority is inviting expression of interest from interested parties for the purpose of assessing interest among parties in the market and most comprehensive and economical proposal will be selected for signing of MoU/Agreement

  - c. Proposed activity mix
  - d. Estimated project cost
  - e. Proposed revenue generation strategy and revenue sharing with ASCL
